

## **MOUNTAIN WEST VOLLEYBALL CODE OF CONDUCT AND FINANCIAL AGREEMENT**

As a parent/guardian of a member of Mountain West Volleyball Club program, I will conduct myself in the manner described below and agree to the following financial arrangements. All responsible parties need to sign that they agree.

1. I understand that I am paying for my child to learn the skills and concepts of volleyball in an effective and respectful environment. Mountain West's coaches will provide a role on the team for every player, but my child will not be guaranteed equal playing time in sets, matches, or tournaments. Decisions concerning player participation in matches and tournaments are solely the responsibility of the coaches.
2. My attendance at matches and tournaments is welcomed and anticipated. I will conduct myself in a respectful manner by:
  1. Showing appropriate sportsmanship toward all teams, parents, fans, officials, coaches, and staff. I will refrain from using loud or profane language.
  2. Being patient and supportive with the athletes, regardless of their play.
  3. Accepting decisions made by coaches and staff.
  4. Discontinuing behavior deemed unacceptable at the request of staff, coaches, players, officials or other fans. If I fail to honor such request, it is within the rights of Mountain West staff or any hosting organizations staff to request that I leave the playing area or the building.
  5. Refraining from distracting my child, other players, and/or coaches during competition.
3. If I have a grievance, I agree to follow the Grievance Policy and Procedures as outlined in the Mountain West Volleyball Club Handbook. I will abide by the grievance resolution decisions that are made as described in the Handbook's procedures.
4. My child must remain at the competition site until released by the team's head coach, both during and after the tournament.
5. I am responsible for my child's conduct. I will be contacted if any problems with my child arise.
6. I agree that I will be financially responsible for all fees assessed relating to my child's participation in Mountain West Volleyball Club's programs, plus any penalties resulting from my failure to meet the terms of this agreement as stated in the Mountain West Handbook and reiterated in this agreement. If I remove my child from Mountain West Volleyball Club, or if my child is suspended, before the end of the season, I am still obligated to pay my child's full season fee assessment, as the rest of the team cannot be expected to pick up my share of the team's expenses.

## FEE PAYMENT POLICY

Assessed fees are to be paid as follows: 1) A non-refundable deposit and signed financial agreement are due immediately following tryouts to secure and guarantee the participants' position on a team; 2) first month's fees are due at the first practice and either; 3a) full remaining balance due the first day of January or 3b) begin following monthly payment plan.

Monthly payments are due the first day of the month starting in December, and every month of the club volleyball season thereafter. If no payment has been made by the 10<sup>th</sup> day of the month, a phone call will be made to inform the responsible party that their athlete is placed on probation until the account is brought current. The player's coach will be informed of the probation. If no payment is made by the 20<sup>th</sup> of the month a second phone call will be made to the responsible party to inform them that their athlete will not be able to participate in practice or tournaments until the account is brought current. The athlete's coach will be informed of the suspension. The responsible party(s) of suspended athletes is still obligated to pay the full season fee assessment (see item number 6 of the agreement).

The club fees to play on that team are \$180 non-refundable deposit and \$125 each month. Additional fees will be assessed if my child agrees to participate in post-season play or travel with a team to an additional tournament not included in the normal club season schedule.

By signing below, I acknowledge and agree to the conditions set forth in the Mountain West Volleyball Club Handbook. All parties that will assume this financial obligation must sign the agreement.
